Application for Temporary Disabled/ Handicap **Placard**

Motor Vehicle Law 39:4-204 through 207 States:

The Chief of Police of each municipality in this state shall issue to any person who has temporarily lost the use of one or more limbs or is temporarily disabled as to be unable to ambulate without the aid of an assisting device or whose mobility is otherwise temporarily limited as certified by a physician, podiatrist or chiropractor...a temporary placard may, however, be renewed one time at the discretion of the Special Services Unit issuing authority for a period of no more than 6 months' duration. The placard shall be displayed on the motor vehicle used by the temporarily handicapped person. A vehicle which has displayed a placard is allowed to park overtime or in a designated handicapped parking space.
